

**AGREEMENT**

Player wishes to participate in tournaments that are sanctioned by Sponsor and that as, a condition of Player's participation, Player agrees to the following:

- Sponsor shall have the absolute right to establish all rules for the tournaments which may be amended from time to time and may be published on Sponsor's web site or in written form and which shall be effective at Sponsor's discretion.
- Sponsor shall have the absolute right to determine who is allowed to participate as a Player in sponsored tournaments, and may refuse participation to anyone, at any time, in Sponsor's sole and absolute discretion.
- Player agrees to abide by all of the rules for play and decorum established by the Sponsor and summarized in the Code of Conduct (published on the Sponsor's website). Sponsor will appoint a Regional Director who will then appoint a Tournament Director to supervise the tournaments within the scope of established rules, and play shall be administered within the absolute discretion of such Tournament Director's judgment, subject only to supervision by the Regional Director and Sponsor.
- Sponsor may set and charge a reasonable fee, payable in advance, for sanctioning the tournaments and for related expenses.
- Unless otherwise determined and approved by Sponsor, no bets, wagers or monetary prizes shall be included in Sponsor's sanctioning of the tournaments, and Player shall not look to Sponsor for any relief should Player participate in such activities outside of Sponsor's rules or control.
- Player shall indemnify and hold Sponsor and anyone acting as an agent for Sponsor (Regional Directors, Tournament Directors etc.) harmless from all claims of alleged improper handling of decorum and rules of the tournaments, and its determination that a Player's behavior is unacceptable in any way.
- Player assumes all risk that a determination by Sponsor or anyone acting as an agent for Sponsor (Regional Directors, Tournament Directors etc.) may be unfavorable to the Player.
- Player assumes all health and accident risks associated with participation in tournaments sanctioned by Sponsor.
- Player acknowledges that the Sponsor's message board is provided as a public forum not regularly monitored by Sponsor and that Sponsor, its officers, directors and agents, have no responsibility for any posting thereon, but reserve the right to remove or edit any posting at any time if Sponsor believes posting is detrimental to Star Tournament Association.
- In the event, either party to this Agreement seeks to enforce any rights or make any claims with respect to this Agreement, or the games played, or the event occurring related thereto, the dispute shall be handled under the auspices of the American Arbitration Association under its Commercial Arbitration Rules, and the party initiating the claim must pay all costs of the arbitrator and AAA fees and charges.
- This Agreement will remain in effect between Sponsor and Player until it is revoked in writing by Player with such revocation sent to Sponsor at the address given above.
